The Ottens recently befriended Ann, a woman who was going through a divorce while receiving chemotherapy for cancer. "Rog and I often go to McDonald's for coffee from the YMCA," remarks Audrey. "And one day Ann asked, 'Can I come along?'" Eventually, Ann received Christ as her Lord and Savior and a week later, she was baptized by Rog and Audrey's pastor. The next day, she passed on to glory with Jesus.
